Once you login inside the application, the system automatically navigates to your MyBIC area as the welcome screen:

The **BIC Process Control interface** can be divided into four main views:

- Side Navigation Bar
- Center Page

- Header Navigation Bar
- Options menus\*

**Figure**: Here you can see the interface of BIC Process Control divided into Side Navigation Bar (1), Center Page (2) and Header Navigation Bar (3).

**Side Navigation Bar**: On the left side of the screen you can find a navigation bar that contains all of the areas that are available to your user role.

Some of these areas may be hidden depending on your role, because each one has different authorizations.

Note: For example, Administrator is the only user role able to visualize the Administration area.

Above these areas you can find the current logo of the application. You can always return to your welcome screen by clicking on it.



Find out how to insert a new logo on this section inside the Administration chapter.

Center Page: The center page will show the content of the different views.

Once again, the content that can be visualized depends on your user role.

**Note:** For example: as a *PARTICIPANT*, inside the Risk Catalogue you only visualize those risks where you participate directly or that are associated with controls on which you participate directly, as a single user or as a member of

a user group. But as an ANALYST you have access to all the existing risks.

Header Navigation Bar: The upper area of BIC Process Control displays the following functionalities:

- Search: From here, you can begin searching for tasks in processes.
- *Hide sidebar* option: It is a clickable button that lets you hide the Side Navigation Bar in order to expand the content of the center page.
- Breadcrumbs: Used to display the section or area inside the application where the user currently is.

Depending on the view that is displayed on the center page, the corresponding breadcrumb entry can contain additional information related to the view that is shown in the center page. For example: the number of tasks that are shown in the *MyBIC* view.

**Options menus**: Options menus offer additional options that are available in the context of the view that is currently shown in the center page. Not all views have the Options bar.

You can hide them by clicking on the blue arrow icon, in order to expand the content of the center page.




Figure: Here you can see the fourth view of the BIC Process Control interface: Options menu (4).

- **Task overview**: The *Task overview* section shows the tasks assigned to you. From here you can directly open, edit and submit them.
- **My evaluation**: The *My evaluation* section contains a chart with your tasks accumulated by status (In Progress, Overdue, Overdue soon).
- Tasks in processes: The Task in processes section shows your tasks in progress classified by type.

If you do not have any assigned tasks yet, instead you are able to visualize the **Create a new process** option for starting a new process.

• My processes: The *My processes* view shows all active processes in which you are involved, with your own tasks. You can use this view to keep track of who has completed tasks in these processes and who still has tasks to do.

#### Filter menu

On the right side of this area you can find the *Filter* menu. This option lets you filter your tasks in processes by using facets.

The available filter categories are: PROCESS, TASK OWNER, STATE, CREATED ON and DUE ON.

Expand a facet in order to see all available facet values, which are dynamically loaded. You can set more than one facet value simultaneously.


The Filter option will only show the State for active tasks: Pending and Overdue.

The same applies to date-pickers fields: only those for still active tasks (CREATED ON and DUE ON) are shown here.

#### 1.1.3 New processes

In the *New processes* area you can start new task-based processes. Depending on the processes for which *Administrators* have given you authorization, these are: *Action Management*, *New Control* and *New Risk*.



### 1.1.4 Catalogues

The Side Navigation Bar allows direct access to the catalogues.



- **Risk Catalogue**: The *Risk Catalogue* view displays, based on your user role, the risks and related details you have access to.
- **Control Catalogue**: The *Control Catalogue* view displays, based on your user role, the controls and related details you have access to.
- Action Management Catalogue: The *Action Management Catalogue* shows a list of active or finished Action Managements.

# 1.2 First steps

#### 1.2.1 How do I create a risk?

Select the *New Risk* view in the *New processes* area. The system shows you a form with the necessary fields for entering a new risk: make sure you fill those that are labelled as mandatory fields (\* symbol). The meaning of the

fields are explained in the section *Terms used in risk management*. With \_\_\_\_\_\_, the risk is added to the risk catalogue.

#### 1.2.2 How do I create a control?

Select the *New Control* view in the *New processes* area. The system shows you a form with the necessary fields for entering a new control: make sure you fill those that are labelled as mandatory fields (\* symbol). The meaning of the fields are explained in the section *Terms of integrated control systems*. You must assign the control to an existing risk.

With **SUBMIT FORM**, the control is added to the control catalogue.

#### 1.2.3 How do I create an action?

Select the *Action Management* view in the *New processes* area. The system shows you a form with the necessary fields for entering a new action: make sure you fill those that are labelled as mandatory fields (\* symbol). The meaning of the

fields are explained in the section *Controlling integrated control systems*. With \_\_\_\_\_\_, the user selected as responsible is given the task of implementing the action.

Note: You can always return to your welcome screen by clicking on the logo at the top left of the screen.

#### 1.2.4 Which user roles are available and which permissions do they have?

In general, there are four different available user roles inside the system: *PARTICIPANT*, *ANALYST*, *SUPERVISOR* and *ADMINISTRATOR*.

Each one of the main four user roles has different authorizations that build on each other.

**Participant:** Users with this role can access all of the areas inside the application, except for the *Administration* panel. Participants are able to start new processes, submit and delegate assigned tasks, and visualize risks and controls where they participate directly or as a member of a user group.

**Analyst:** Users with this role have limited access inside the application. Analysts are not able to start new processes, but they can submit and delegate assigned tasks. They can visualize catalogues in full detail.

**Supervisor:** Similar to the Participants, users with this role can access all of the areas inside the application, except for the *Administration* panel. They are able to start new processes, submit and delegate assigned tasks, and in addition they can also visualize catalogues in full detail.

Administrator: Users with this role hold all the rights that other user roles have. In addition, they have special rights by being able to access the *Administration* area.

# CHAPTER 2

## Basics of risks management and integrated control systems

## 2.1 Terms of risks management

**Risk Identification**: Risk identification includes everything that leads you to recording a risk for assessment and further control. You have the following options:

- Process *New Risk*: This allows you to record the risk in one step. Then, it appears immediately in the risk catalogue and is highlighted as a still *Not approved* risk. For a new risk, the name of the risk and the *Risk Owner* must be specified so that a risk assessment is possible. All other input fields depend on the settings of your system.
- Process *Registration Of Risks*: If you want new risks to be confirmed by those responsible before they appear in the risk catalogue, multi-level recording and approval is available. The new risk must be approved by the *Risk Owner* in first place, and later by the *Risk Category Responsible* (another overriding role, e.g. a central risk manager). Both roles can also reject the risk or send it back to the previous process if the information is incomplete or incorrect.
- Transfer of risks from diagrams in BIC Process Design: When diagrams are published in BIC Process Design, risks can be transferred automatically by using the *Publish* feature.

**Risk Control**: Risk management includes all activities to reduce the probability and impact of the risks. Considering these fields, the software automatically calculates the *Risk Rating*.

- If a risk is accepted, activities only follow when the risk has actually occurred.
- When a risk is transferred, another organization (e.g. an insurance company) takes over the impact. This results in, at least, one activity to agree on a contract to take over the *Risk Impact*. The *Action Management* process is available for planning and tracking this activity.
- If avoided, the risk effects on your own company should be avoided entirely (not only reduced). Since business activities involve risks, the corresponding business activities must be abandoned to avoid them.
- If there is a reduction, you have to plan and implement activities that have a favorable effect on the probability or on the impact. The *Action Management* process is available for a one-time activity. In general, however, regular activities are necessary for permanent reduction and controls are available for this.

**Risk Assessment**: It includes the assessment of the risk *Probability* and *Impact*, as well as the decision of which response should be taken (acceptance, transfer, avoidance, mitigation) by the *Risk Owner*. A higher-level role can be included to check the risk assessment, e.g. a central risk manager, as a *Risk Category Responsible*.

**Test of Completeness:** The *Risk Owner* should regularly review whether the risk is fully managed through appropriate activities. If you want to reduce a risk, the *Risk Owner* should assess whether the likelihood of occurrence and the extent of the risk are sufficiently reduced by the assigned controls, or whether there are gaps that have not yet been completely covered by controls or actions.

Action Management: If risks do occur, activities to limit and regulate the impact become necessary. The *Action Management* process is available for planning and tracking this type of activities.

Hint: It is possible to manage who is allowed to start a specific type of process. See Processes administration.

# 2.2 Terms of integrated control systems

**Control Identification**: Control identification includes everything that means that you need to record a control to mitigate a certain risk. You have the following options:

- Process *New Control*: This allows you to record the control in one step. Then, it appears immediately in the control catalogue and is highlighted as a still *Not approved* control. For a new control, the name of the control, the assigned risk and the *Control Owner* must be specified so that an inspection is possible. All other input fields depend on the settings of your system.
- Process *Registration Of Controls*: If you want new controls to be confirmed by those responsible before they appear in the control catalogue, multi-level recording and approval is available. The control must be approved by the *Control Owner* in first place, and later by the *Risk Owner* of the assigned risk. Both roles can also reject the control or send it back to the previous process if the information is incomplete or incorrect.
- Transfer of controls from diagrams in BIC Process Design: When diagrams are published in BIC Process Design, controls that are already assigned to risks can be transferred automatically by using the *Publish* feature.

**Test of Design**: The *Control Owner* must regularly check whether the control activity and execution intervals are suitable to adequately reduce the risk. If the *Control Owner* does not consider the control to be appropriate, the *Action Management* process is started in order to plan and track the activities to restore adequacy.

**Test of Effectiveness of Controls**: The *Control Tester* must regularly check whether the control is actually and effectively carried out. If the *Control Tester* does not consider the control to be appropriate, the *Action Management* process is started in order to plan and track the activities to restore effectiveness.

**Performance of Controls**: You can document the performance of the activity described as a control in the system with the process *Performance of Controls*. The process is started regularly for controls with defined execution intervals. For controls without an execution interval, you can start the process in the control catalogue. The process is always assigned to the person who is entered as the *Execution of Control*. If deviations are discovered during the control process, the *Action management* process is started in order to plan and track the reaction to those deviations.

Action Management: The control system consists of planning and monitoring the processing of all processes. Planning is carried out by setting dates and execution intervals for all processes. The software takes over the start of the processes, as well as the monitoring of the deadlines for these processes, so you can fully focus on further developing the control system and correcting deviations.

Hint: It is possible to manage who is allowed to start a specific type of process. See Processes administration.

# CHAPTER 3

### Tasks

### 3.1 Task lists

In the *Running processes* area, tasks can be found in the *My tasks*, *My processes* and *Delegated tasks* as lists, as well as using the *Search* option. These lists contain the following information for each task:



1. Chip: The user chip shows who is assigned to a specific task. Depending on the appearance of the user chip, the

user can distinguish if a task is assigned to a user  $\bigcirc$  or to a user group  $\bigcirc$ . If you hover the mouse over the chip then the user name is shown.

**2.** Task type: The task type determines the sequence of tasks in a process workflow (e.g. Risk Assessment, Action Management, Test of Completeness...).

3. Description: The description conveys what needs to be done in this task.

4. ID: One unique identifier is assigned to each task.

5. Task created: This date indicates when the task was created.

**6. Task due**: This date indicates when the task must be completed. From the day after, the task is shown as *Overdue*. A few days before this date, the task will be shown as *Overdue soon*. The exact number of days depends on the settings of your system: the default number is three days. If the task is assigned to yourself, you can bring the date forward to be reminded earlier. If you have brought the date forward, you can set it back to a later date, but never later than the original due date.

You can open tasks by clicking on them, to see what information they currently have. If the task is active and assigned to yourself, you can also edit and complete the task directly from this area.

Hint: A task belongs to a given process instance. Process instances can be created:

- Manually by the user.
- Automatically by the system on a scheduler based approach.
- Automatically by the system as a result of a previous process instance.

# 3.2 Task actions

You can perform the following actions hovering the task and clicking on the *Actions menu* button (\*\*\* three dots on the right side) of each task:

Audit trail: Audit trail shows you the description and the executing user of all completed, delegated and still open tasks in a process.

**Delegate task**: You can delegate a task that is assigned to you to another user. Then, this user is able to edit and complete the task without restrictions. Keep in mind that once you delegate a task, you are not able to take it back to yourself. If you want to consult another user but without delegating the task, you can use the *Send message* function. Users with the *Supervisor* or *Administrator* role can also delegate tasks that are not directly assigned to them.

**Send message**: You can send a link to the tasks to another user, to notify or to consult him/her. Every user role is able to open the link to the task in a read-only mode. Only the user that is assigned to the task is able to change content or to submit the task.

**Cancel process**: As a *Supervisor* or *Administrator* you are able to cancel the whole process. When you select this option, you must give a reason for cancellation. Users with different roles (like *Participant* or *Analyst*) are not able to visualize this option.

Note: Further information about cancelling processes can be found here.

Comments: Users can add comments to tasks, and also view the comments added by other users.

Attachments: Users can add attachments to processes, and also view the attachments added by other users.

#### 3.2.1 How can I cancel a process?

Every task belongs to a process instance. For example, the task Assess risk belongs to the process Risk Assessment.

Depending on the user role, it is possible to cancel a process:

- As a Participant or Analyst the option Cancel process is not available.
- As a *Supervisor* or *Administrator* you are able to cancel processes at any time: click on the *Actions menu* button of a particular task and select the *Cancel process* option.

If a user chooses the *Cancel process* option, it is mandatory to define a reason for cancellation. After confirming this action, the process instance will be cancelled and each participant will be informed by email.

Also, all active tasks of the cancelled process instance will disappear from the corresponding task views (*My tasks*, *My processes* and *Delegated tasks*).

You can still find finished tasks of a cancelled process using the Search option:

- All former finished tasks of the cancelled process instance are still available as *Done* tasks.
- The last active task is shown as a *Done* task after the cancellation.

Warning: You cannot restart cancelled processes.

If the process was started by the scheduler based on the given interval, it is not possible to restart a process instance for that old interval period again.

For example, if there is a risk that has *Annually* as *Interval for Risk Assessment* and was started by the scheduler on 02.05.2019, after the creation of the **Risk Assessment**, the *Next Risk Assessment* is set to 02.05.2020 inside the *Risk Catalogue* in order to prepare it for the next iteration. If now someone cancels this process instance that represents the **Risk Assessment** for the risk in the year 2019, there is no way to restart an instance that counts for that period. The only way would be to start manually a **Risk Assessment** and describe in the comment that it is a replacement for the year 2019.

# 3.3 Group tasks

A task can be assigned to a single user or a single user group. If a task is assigned to a user group, it means that all group members have this task listed in the *My tasks* view and are informed by email. But finally, only one user will do the task on behalf of the group.

When a user decides to take care of a task and opens a group task by clicking on it, the user is officially claiming it. Therefore, the user becomes the only assignee for that specific task and the task disappears from the *My tasks* list for all other group members.

Hint: Trace data in the Audit trail will reflect the user who has performed the task, not the group.

As the process instance forwards, all group members become potential assignees and users can individually claim assigned tasks again.

**Note:** If a user is added to the user group after creating a group task, the user will have access to the task as long as it was not claimed yet by another member of the group.

### 3.3.1 Can I delegate a group task?

You can delegate a group task to a different user or user group, independent if the group task is already claimed or not. In any case, after the delegation, the group task will disappear from the former assignees and will appear on the My tasks views for the new assignees.

Note: Further information about delegating a task can be found *here*.

# 3.4 Task notifications

In BIC Process Control there exists a notifications system with which users can be informed about events related to tasks they are involved in, as single users or as members of a group.

These notifications are automatically sent by the system via email, and can be classified into two main categories according to their frequency: **daily notifications** and **instant notifications**.

Also, each notification has a different Subject line and body so users can easily distinguish them.

### 3.4.1 Daily notifications

As a daily notification, a user will receive one single email containing all events which happened since his last notification. The following types of events will be collected inside the daily notification:

- New assigned tasks.
- Overdue soon tasks that are not finished yet.
- Overdue tasks that are not finished yet.

For each type of event there is a different section in the email showing the corresponding tasks sorted by:

- 1. Due date of the task.
- 2. Process type.

The following picture shows the daily email sent to a user with only one new assigned task since the last notification. Therefore, the sections **Overdue soon tasks (sort by due date)** and **Overdue tasks (sort by due date)** are not displayed as part of the email notification.

### 3.4.2 Instant notifications

In comparison with the daily notification, for each of the following events an individual email notification will be generated:

- After commenting a task.
- After cancelling a process.

In addition to these two notification types, the system will also send an email notification for a delegated task. But this will only happen when the delegated task has its due date today or counts already as overdue.

# 3.5 How can I export my tasks?

On the right side of the *Running processes* view there is the *Options* menu bar, which provides an export option in the form of a downloadable .XLSX file.



By clicking on *EXPORT* you download your tasks that are visible to you. (Based on the view, your user role and active filters)

# 3.6 How can I do a bulk delegation of tasks?

As an Administrator you can execute a bulk task delegation inside the **Search** view. Once a search term is entered and a result is shown, the system will offer a kebab menu on the right side of the area containing the search input field.

If the option *Bulk delegate tasks* is selected, similar to a single task delegation, a new task owner (user or user group) must be selected and a reason for the delegation must be entered. In difference to a single task delegation, the bulk operation needs an additional confirmation interaction. This is necessary in order to prevent an accidentical trigger of this action.

Once the confirmation is made and the *DELEGATE TASKS* button is triggered, the system will automatically delegate all active tasks that are currently visible in the same way as they would be delegated individually. The currently visible tasks are defined based on the search term and selected filter facets. *Finished* and *Canceled* tasks will be ignored.

The execution of the bulk operation and their end is indicated by a message on the lower right corner of the screen.



**Hint:** After the end of the bulk operation, the system may take a bit to update the task cards with the new task owner. This depends on the number of affected tasks. Refreshing the view by pressing F5 on your keyboard will show you the changes.

# 3.7 How can I do a bulk cancellation of processes?

As an Administrator you can execute a bulk process cancellation inside the **Search** view. Once a search term is entered and a result is shown, the system will offer a kebab menu on the right side of the area containing the search input field.

If the option *Bulk cancel processes* is selected, similar to a single process cancellation, a reason for the cancellation must be entered. In difference to a single process cancellation, the bulk operation needs an additional confirmation interaction. This is necessary in order to prevent an accidentical trigger of this action.

Once the confirmation is made and the *CANCEL PROCESSES* button is triggered, the system will automatically cancel all processes for all active tasks that are currently visible in the same way as they would be cancelled individually. The currently visible tasks are defined based on the search term and selected filter facets. *Finished* and *Canceled* tasks will be ignored.

The execution of the bulk operation and their end is indicated by a message on the lower right corner of the screen.



**Hint:** After the end of the bulk operation, the system may take a bit to update the task cards. This depends on the number of affected tasks. Refreshing the view by pressing F5 on your keyboard will show you the changes.

# CHAPTER 4

## **BIC Process Control Processes**

### 4.1 New Risk

#### 4.1.1 Who is involved inside this process?

Despite all the other risk related processes, the *New Risk* process does not involve specific roles like the *Risk Owner*. Everyone who can see the tile *New Risk* inside the *New processes* view is able to register a new risk into the Risk

Catalogue. Every risk created that way, will be shown as "Not approved"  $\P$ .

#### 4.1.2 Which tasks are part of this process?

In the *New Risk* process, only the initial entry form needs to be completed. After submitting the form, the new risk is listed directly inside the Risk Catalogue.

The entry form contains some mandatory fields, so that the most important information about the risk is entered directly. Among other things, the *Risk Owner* and the *Risk Category Responsible* are recorded. An initial qualitative risk assessment specifying the *Impact* and *Probability* is also requested. The actual *Risk Rating* is determined automatically.

Note: *Here* you can see how the system calculates the corresponding rating according to certain business rules.

### 4.1.3 When and how is the Action Management process triggered?

After submitting the New Risk form, depending on the user inputs the system may start an Action Management.

The Action Management process is triggered when:

• The Next Risk Assessment selected date is later than 30 days from the current date.

The Action Management process starts by informing that "The date for next risk assessment is too late", so it requires the *Risk Owner* to take appropriate actions that will be reviewed again by higher-level roles.

Regardless of when and how the Action Management was triggered, the first task of this new process also contains a link to the corresponding risk and four fields whose content is predefined by business logic rules.

The entries below are the fields of the Action Management process that are prefilled with specific data:

Action Management field	How is it prefilled?
Responsible for Implementation	Risk Owner
Authority in Case of Escalation	Risk Category Responsible
Due date	Today + 30 days
Review due	Today + 45 days

Even if the above list of fields contains predefined content, their values can be adopted inside the Define action task.

# 4.2 Risk Assessment

#### 4.2.1 Who is involved inside this process?

The users involved through this process are the *Risk Owner* and the *Risk Category Responsible*, considering this second one as a higher-level role that will review the values and dates previously selected by the first one. Both fields can be assigned to the same user or user group, but they can also be assigned to different users or user groups.

Here you can see how group tasks are handled.

#### 4.2.2 Which tasks are part of this process?

This process consists of up two different tasks:

- The primary Assess risk task
- The secondary Review assessment task, which will be triggered based on predefined business rules

After the process is manually or automatically launched, the first task requires the *Risk Owner* to assess the corresponding risk:

- If the *Risk Owner* just confirms the risk as it is again, the process is finished right after submitting the form.
- If there are changes (different *Risk Rating* or *Risk Response* values, or risk rated as **Obsolete**) and there is an assigned *Risk Category Responsible*, the process moves to the second task in order to perform a **re-assessment**.

Note: After the end of a process where the risk is rated as *Obsolete*, the  $\ge$  icon will be displayed next to it.

During the **re-assessment** task, the assigned user has to define the *Result of Re-assessment* by choosing between two different options:

- I confirm the risk assessment: the values of the assessed risk are updated in the catalogue and can be visualized as part of the risk details view.
- I reject the risk assessment for correction by the risk responsible: the values of the assessed risk are rejected and the process returns to the first task, which requires the *Risk Owner* to perform a new evaluation of the risk. Once this form is submitted, the **Review assessment** task is required again.

**Hint:** After updating the corresponding risk inside the Risk Catalogue, the system will also update it inside BIC Process Design if the risk was formerly imported by using the *connector*.

#### 4.2.3 How is the risk rating calculated?

Once the *Impact* and *Probability* values are selected by the involved users, the system calculates the resulting *Risk Rating* by following certain business rules configured through a DMN (Decision Model and Notation) table.

The **Risk Assessment** process also offers fields to maintain the Risk Assessment from an operational risk management perspective:

- Impact (EUR)
- Probability (%)
- Risk Expectation (EUR).

These fields are optional and the field **Risk Expectation** (**EUR**) will be automatically calculated based on the inputs of the other two fields.

#### 4.2.4 When and how is the Action Management process triggered?

After finishing the Risk Assessment process, depending on the user inputs the system may start an Action Management.

The Action Management process is triggered when:

- The *Risk Rating* value is changed (increased or decreased).
- The Risk Response value is changed.
- The risk is rated as **Obsolete**.

The Action Management process starts by requiring the *Risk Owner* to take appropriate actions that will be reviewed again by higher-level roles.

Regardless of when and how the Action Management was triggered, the first task of this new process also contains a link to the corresponding risk and four fields whose content is predefined by business logic rules.

The entries below are the fields of the Action Management process that are prefilled with specific data:

#### 4.2.5 How is the "Next Risk Assessment" date calculated?

When a process is started automatically, BIC Process Control calculates the *Next Risk Assessment* based on the *Interval for Risk Assessment*. In this case, the corresponding risk is updated with the new *Next Risk Assessment* date. This will lead to a new risk version inside the *History* section.

When a process is manually started from the *Risk Catalogue*, it is counted as an additional instance on top of the automatically generated one.

# 4.3 Test of Completeness

#### 4.3.1 Who is involved inside this process?

The user involved through this process is the Risk Owner. This field can be assigned to a single user or to a user group.

### 4.3.2 Which tasks are part of this process?

This process consists of the task Test the completeness of coverage of the risk by controls.

After the process is manually or automatically launched, the related task requires the *Risk Owner* to test if the risk is completely covered with controls.

In order to verify that, the *Result of Test of Completeness* field offers two possible options: **Controls are complete** or **Controls are insufficient**.

If the *Risk Owner* selects **Controls are complete** and the *Risk Response* is not **Mitigation**, the process is finished right after submitting the form.

**Hint:** After updating the corresponding risk inside the Risk Catalogue, the system will also update it inside BIC Process Design if the risk was formerly imported by using the *connector*.

### 4.3.3 When and how is the Action Management process triggered?

After finishing the Test of Completeness process, depending on the user selection the system may start an Action Management.

The Action Management process is triggered when:

- The Result of Test of Completeness is Controls are complete and the Risk Response is Mitigation.
- The Result of Test of Completeness is Controls are insufficient.

The Action Management process starts by requiring the *Risk Owner* to take appropriate actions that will be reviewed by higher-level roles.

Regardless of when and how the Action Management was triggered, the first task of this new process contains a link to the corresponding risk and five fields whose content is predefined by business logic rules.

The following table shows how these rules are applied to the Action Management process:

Reviewer	Risk Category Responsible
Authority in Case of Escalation	Risk Category Responsible
Due date	Today + 30 days
Review due	Today + 45 days

Even if the above list of fields contains predefined content, their values can be adopted inside the Define action task.

### 4.3.4 How is the "Next Test of Completeness" date calculated?

When a process is started automatically, BIC Process Control calculates the *Next Test of Completeness* based on the *Interval for Test of Completeness*. In this case, the corresponding risk is updated with the new *Next Test of Completeness* date. This will lead to a new risk version inside the "History" section.

When a process is manually started from the *Risk Catalogue*, it is counted as an additional instance on top of the automatically generated one.

# 4.4 New Control

#### 4.4.1 Who is involved inside this process?

Despite all the other control related processes, the *New Control* process does not involve specific roles like the *Control Owner*. Everyone who can see the tile *New Control* inside the *New processes* view is able to register a new control

into the Control Catalogue. Every control created that way, will be shown as "Not approved" 👎.

#### 4.4.2 Which tasks are part of this process?

In the *New Control* process, only the initial entry form needs to be completed. After submitting the form, the new control is listed directly inside the Control Catalogue.

The entry form contains some mandatory fields, so that the most important information about the control is entered directly. Among other things, the *Control Owner* and the *Control Tester* are recorded. Information on the *Effect of Control*, the *Type of Performance* and the *Execution interval* is also requested.

In order to complete the recording of the control, the new control must be assigned to a risk.

#### 4.4.3 When and how is the Action Management process triggered?

After finishing the New Control process, depending on the user inputs the system may start an Action Management.

The Action Management process is triggered when:

• The Next Test of Design selected date is later than 30 days from the current date.

The Action Management process starts by informing that "The date for next test of design is too late", so it requires the *Control Owner* to take appropriate actions that will be reviewed again by higher-level roles.

Regardless of when and how the Action Management was triggered, the first task of this new process also contains a link to the corresponding control and four fields whose content is predefined by business logic rules.

The entries below are the fields of the Action Management process that are prefilled with specific data:

Action Management field	How is it prefilled?
Responsible for Implementation	Control Owner
Authority in Case of Escalation	Risk Owner (of the associated risk)
Due date	Today + 30 days
Review due	Today + 45 days

Even if the above list of fields contains predefined content, their values can be adopted inside the Define action task.

# 4.5 Test of Design

#### 4.5.1 Who is involved inside this process?

The user responsible of this process is the *Control Owner*. This field can be assigned to a single user or to a user group during the creation of a new control.

### 4.5.2 Which tasks are part of this process?

This process consists of the task Test design of control.

After the process is manually or automatically launched, the related task requires the *Control Owner* to test the design of the selected control.

In order to verify that, the *Result of Test of Design* field offers two possible options: **Inappropriate design of control** or **Appropriate design of control**.

By selecting **Appropriate design of control**, the process is finished right after submitting the form and the control details are properly updated.

Below this field, there is a checkbox that can be used in order to Rate control as obsolete.

Note: After the end of a process where the control is rated as *Obsolete*, the  $\ge$  icon will be displayed next to it.

If this checkbox is selected, only the field *Comment on Result of Test of Design* is mandatory. By unselecting it the original mandatory fields are mandatory again.

**Hint:** After updating the corresponding control inside the Control Catalogue, the system will also update it inside BIC Process Design if the control was formerly imported by using the *connector*.

### 4.5.3 When and how is the Action Management process triggered?

After finishing the Test of Design process, depending on the user selection the system may start an Action Management.

The Action Management process is triggered when:

- The Result of Test of Design is Inappropriate design of control.
- The control is rated as **Obsolete**. Also, in this particular case it is not needed to select the result of the test, and the system will not require a higher-level role to review this new rating.

The Action Management process starts by requiring the *Control Owner* to take actions for appropriate design of the control that will be reviewed by higher-level roles.

Regardless of when and how the Action Management was triggered, the first task of this new process contains a link to the corresponding risk and five predefined fields.

The following table shows how these rules are applied to the Action Management process:

Action Management field	How is it prefilled?
Responsible for Implementation	Control Owner
Reviewer	Risk Owner
Authority in Case of Escalation	Risk Owner
Due date	Today + 30 days
Review due	Today + 45 days

Even if the above list of fields contains predefined content, their values can be adopted inside the Define action task.

### 4.5.4 How is the "Next Test of Design" date calculated?

When a process is started automatically, BIC Process Control calculates the *Next Test of Design* based on the *Interval for Test of Design*. In this case, the corresponding control is updated with the new *Next Test of Design* date. This will lead to a new control version inside the *History* section.

When a process is manually started from the *Control Catalogue*, it is counted as an additional instance on top of the automatically generated one.

# 4.6 Test of Effectiveness of Controls

### 4.6.1 Who is involved inside this process?

The user responsible of this process is the *Control Tester*. This field can be assigned to a single user or to a user group during the creation of a new control.

#### 4.6.2 Which tasks are part of this process?

This process consists of the task Test effectiveness of control.

After the test is manually or automatically launched, the related task requires the *Control Tester* to test the effectiveness of the corresponding control.

In order to verify that, the *Result of Test of Effectiveness* field offers three possible values: **Control is not effective**, **Control is partly effective** or **Control is effective**.

When selecting **Control is effective**, the process is finished right after submitting the form and the control details are updated.

**Hint:** After updating the corresponding control inside the Control Catalogue, the system will also update it inside BIC Process Design if the control was formerly imported by using the *connector*.

### 4.6.3 When and how is the Action Management process triggered?

After finishing the Test of Effectiveness of Controls process, depending on the user selection the system may start an Action Management.

The Action Management process is triggered when:

• The Result of Test of Effectiveness is Control is not effective or Control is partly effective.

The Action Management process starts by requiring the *Control Owner* to take appropriate actions for the effectiveness of the control, that will be reviewed by higher-level roles.

Regardless of when and how the Action Management was triggered, the first task of this new process contains a link to the corresponding risk and five predefined fields.

The following table shows how these rules are applied to the Action Management process:

Authority in Case of Escalation	Risk Owner

#### 4.6.4 How is the "Next Test of Effectiveness" date calculated?

When a process is started automatically, BIC Process Control calculates the *Next Test of Effectiveness* based on the *Interval for Test of Effectiveness*. In this case, the corresponding control is updated with the new *Next Test of Effectiveness* date. This will lead to a new control version inside the *History* section.

When a process is manually started from the *Control Catalogue*, it is counted as an additional instance on top of the automatically generated one.

## 4.7 Performance of Controls

#### 4.7.1 Who is involved inside this process?

The user responsible of this process is the *Execution of Control*. This field can be assigned to a single user or to a user group during the creation of a new control.

### 4.7.2 Which tasks are part of this process?

This process consists of the task **Perform control**.

After the process is manually or automatically launched, the related task requires the *Execution of Control* to test the performance of the corresponding control.

In order to verify that, the *Result of Performance of Control* field offers three possible options: **Ok**, **Minor deviations** or **Major deviations**.

By selecting Ok, the process is finished right after submitting the form and the control details are properly updated.

**Hint:** After updating the corresponding control inside the Control Catalogue, the system will also update it inside BIC Process Design if the control was formerly imported by using the *connector*.

## 4.7.3 When and how is the Action Management process triggered?

After finishing the Performance of Controls process, depending on the user selection the system may start an Action Management.

The Action Management process is triggered when:

• The Result of Performance of Control is Minor deviations or Major deviations.

The Action Management process starts by requiring the *Control Owner* to take appropriate actions against deviations in the performance of the corresponding control, that will be reviewed by higher-level roles.

Regardless of when and how the Action Management was triggered, the first task of this new process contains a link to the corresponding risk and five predefined fields.

### 4.7.4 How is the "Next Performance of Control" date calculated?

When a process is started automatically, BIC Process Control calculates the *Next Performance of Control* based on the *Execution Interval*. In this case, the corresponding control is updated with the new *Next Performance of Control* date. This will lead to a new control version inside the *History* section.

When a process is manually started from the *Control Catalogue*, it is counted as an additional instance on top of the automatically generated one.

## 4.8 Action Management

### 4.8.1 Who is involved inside this process?

The roles involved through this process are: Responsible for Implementation, Reviewer and Authority in Case of Escalation.

These roles can be assigned to the same single user or user group, but also to different users or user groups.

The user or user group assigned as *Reviewer* or *Authority in Case of Escalation* must be different to the *Responsible for Implementation*.

### 4.8.2 Which tasks are part of this process?

Three tasks are part of this process:

- Define action
- Implement action
- Review implementation of action

In addition to these three tasks, there is a **Manage escalation of action** task available, which will be triggered under specific circumstances.

The **Define action** task, as the first one of this process, must indicate the name of the **Corrective Action** and also its **Priority** (Low, Medium, High) and **Type**. The *Responsabilities* section inside this form indicates which users or user groups will be assigned as *Responsible for Implementation*, *Reviewer* and *Authority in Case of Escalation*. Regarding the dates, **Due date** and **Review due** fields are also part of this form.

The content and values for these fields must be completely entered by the user if the process was launched manually. If it was launched automatically, data inside some of them will be directly predefined by the system according certain rules.

Hint: You can find out more about this topic here.

The second task of this process is **Implement action**, which is assigned to the user previously selected as *Responsible for Implementation*.

During this task, the responsible user is required to select the current *Status of Implementation*. This field contains five possible values: Pending, Implemented, Duplicate, Invalid, and Obsolete. Also, the form requires a comment regarding the selected status.

Once this second task is submitted, the third task of the process is **Review implementation of action**, which is assigned to the *Reviewer*.

In the corresponding form, the *Reviewer* needs to decide the *Measure approval*. There are two possible results:

- Approve implementation. This way, the process is finished right after submitting the form.
- **Reject implementation**. This way, the process returns to the second task, which requires the *Responsible for Implementation* to perform again the implementation of the action.

The last task of this process is **Manage escalation of action**, which is assigned to the user or user group selected as *Authority in Case of Escalation*.

This task is automatically triggered when the **Due date** for implementation or the **Review due** date is reached.

#### 4.8.3 When and how can the Action Management process be launched?

This process can be launched *manually* or *automatically*.

The process is started manually when:

- The user creates a new Action Management process from the New processes section.
- The user starts a new **Action Management** process from the context menu of already existing risks or controls inside the catalogues.

Hint: It is possible to manage who is allowed to start a specific type of process. See *Processes administration*.

The process may be started automatically as a result of the following processes:

- Risk Assessment
- Test of Completeness
- Test of Design
- Test of Effectiveness of Controls
- Performance of Controls

When the process is started automatically, certain fields of the first *Define action* task will be already filled with predefined data: *Responsible for Implementation, Reviewer, Authority in Case of Escalation, Due date* and *Review due*.

Depending on the process which started the Action Management, the values for these fields can vary. For further details, please check the corresponding question **When and how is the Action Management process triggered?** for each process.

### 4.8.4 When and how a Manage escalation task is triggered?

A Manage escalation task is triggered when:

- an Implement action task is active and the defined due date for implementation has passed.
- an *Review action* task is active and the defined due date for the review has passed.

In both cases the escalation task will be assigned to the user / user group which is defined as *Responsible in case of escalation*.

### 4.8.5 What happens after finishing a Manage escalation task?

When a manage escalation task is finished, the next step inside the Action Management process depends on the input that was made during the escalation task.

One of the following steps can happen next:

- When there is no Implementation status set AND the Due date for implement the action is set to the future.
  - Then the process will create a *Implement action* task.
- When the field *Measure approval* is still empty, a *Reviewer* is defined AND review due date is in the future.
  - Then the process will create a *Review action* task.
- In all other cases the Action Management process is finished.

# CHAPTER 5

# **Risk Catalogue**

### 5.1 Overview

Considering the different user roles, in the Risk Catalogue you can find:

- Table view of the risks you have access to and the essential information for each one.
- Dashboard view of your risks for each facet that is available.
- Heatmap that shows you the distribution of risks based on Probability per Impact.
- All three views offer different perspectives for further analysis of your risks.

You can also find on the right side of the catalogue a menu bar with two available tabs: *Filter* and *Options*. *Options* offers you the possibility to *EXPORT* the complete *Risk Catalogue* and download the *RISK CONTROL MATRIX*.

### 5.1.1 How the role of a user changes the risks I can see?

The Risk Catalogue shows you risks based on your assigned role.



The Table shows you recorded risks you have access to and the essential information for each one.

If a risk is not approved yet, you will see a green exclamation mark  $\bigoplus$  on the left side: this means the *Risk Assessment* is still pending.

Hint: You can find more about how to add risks into the catalogue here.

From the context menu of each risk (three dots on the right side <sup>1</sup>) you are able to:



- See the full risk *Details*.
- *Show controls* assigned to a risk.
- See the Action Managements of a given risk.
- See the *Pending tasks* of a given risk.

- See previous information and assessments of a risk in the *History* section, and track back every entry in the history of the corresponding risk.
- Start the following processes *Risk Assessment*, *Test of Completeness*, *New Control* and *Action Management* for a risk.
- When using the process New Control, the new created control will be associated directly to the selected risk.

### 5.2.1 How can I distinguish if a risk is active or obsolete?

You can easily do this by using the "STATE" option, available on top of the Filter menu (right side of the screen).

This option has two possible values that can be selected:

• Active: By selecting this value, you will visualize only those risks which are currently active. Therefore you can start new processes related to these risks.


Active risks will be displayed with the  $\P$  icon or with no icon at all to their left.

• **Obsolete**: By selecting this value, you will visualize only those risks which have been rated as Obsolete. A risk can be rated as obsolete during the *Risk Assessment* process or through the connector. In detail, when a diagram gets depublished, all risks of this diagram will be obsolete. The same goes for a risk that is removed from a diagram.

Obsolete risks will be displayed with the  $\cong$  icon to their left and it is not possible to start new processes for them.

### 5.2.2 How can I know if a risk has associated controls?

Inside the context menu button , you can access *Show controls*.



By clicking on it, you can access a list of all controls associated with each risk.



### 5.2.5 How can I export a risk to a PDF file?

To export a risk to a PDF file, follow these steps:

- 1. Open the details view of the risk (by clicking on the entry or using the context menu).
- 2. On the right side of the details view, you will find a button <. This button provides access to the *Options* side menu.
- 3. Click *Export PDF*  $\stackrel{\bullet}{\checkmark}$  Export PDF to download the PDF file.
- 4. Once the download is complete, open the file to visualize its content.

The PDF includes all the information present in the details view. If a process was involved to create this version of the risk, then the PDF file also contains the audit trail of that process.

**Note:** In order to create PDF files of historical versions, switch to the *History* view of the risk. Then open the details of the desired version and follow Steps 2 to 4.

### 5.2.6 How can I sort entries in the Table view?

You have the option to sort catalogue entries by column headers. When holding the mouse pointer over a specific column header, if the column is sortable, a clickable icon with the shape of an arrow appears  $\uparrow$ .

By clicking on the arrow, the selected column is sorted. Depending on the data type, columns can be sorted alphabetically (A to Z) or by date (oldest/earliest dates).




The sorting order can be inverted by clicking again on the arrow.

The direction of the arrow points upwards or downwards in relation to the current sorting order. The last selected column is marked with a static arrow.

# 5.3 Dashboard view



The Dashboard view offers a chart for each facet that is available and shown as a multi-value selection facet.

### 5.3.1 How are the charts sorted inside the Dashboard view?

The charts are sorted following the same order as the facets available in the *Filter* menu.

### 5.3.2 Based on which data the charts are calculated?

The data is based on the risks that you can see according to your *role* and on the active *filter* facets.

### 5.4 Heatmap

The *Heatmap* shows you an analysis of risks based on two different risk properties. Initially the distribution of risks regarding "Probability" and "Impact" is shown.



Further analysis of your risks can be performed by modifying the axes of the *Heatmap*.

You also have the option to explore in-depth details using the drill down function.

You can drill down by clicking on a given cell of the *Heatmap*, which will redirect you to the *Table* view just showing risks that belong to the chosen cell. To achieve that, the corresponding filter values that represent the cell are activated in the *Filter* option.

Once you have made the drill down, using the browser back button you can navigate back to your previous *Heatmap* view.

#### 5.4.1 Based on which data the Heatmap is calculated?

The *Heatmap* takes into account all risks in the *Risk Catalogue* that are available for a given user based on his *role* and on the active *filter* facets.

#### 5.4.2 What is the sort order for each axis?

The legend is sorted in the same logical order as it is shown inside the forms (e.g. Very Low, Low, Medium, High for the risk property *Impact*).

The x-axis is sorted from left to right and the y-axis is sorted from bottom to top. As a result of this, the upper right corner of the *Heatmap* represents the highest value and the lower left corner represents the lowest value in the meaning of sorting the axes.

### 5.4.3 How filtering affects the Heatmap?

When you select values in the *Filter* facets, the *Heatmap* will only consider those risks that match the selected filtering criteria.

If an active Filter facet is used as an axis in the Heatmap, only the selected facet values are shown inside the axis.

### 5.5 Filter

#### 5.5.1 How can I filter catalogue entries?

If you enter the *Risk Catalogue*, you will find the *Filter* menu on the right side. The *Filter* shows you a list of facets based on your catalogue entries.

Facets can be expanded or collapsed by clicking on them. Among the different filtering options, you can find multiselection pickers, date pickers and numerical values.

• Multi-selection pickers:

#### Multi-selection pickers are shown in two different ways, depending on their number of facet values:

- simple multi-selection facet
- quick-filter multi-selection facet

If the facet contains more than 15 entries it will be rendered as quick-filter multi-selection facet.


#### Simple multi-selection facet

When you open a simple multi-selection facet, you can see the total number of how many risks match each filter value.

Filter values are sorted in descending order from the highest number of matching hits to the lowest. If two or more filter values happen to have the same number of hits, then filters are alphabetically sorted in ascending order.


Multiple selections can be undone by clicking again on the selected facet values or by using the remove option.

Each facet header indicates the number of active facet values that are used to filter the *Risk Catalogue*. For example, 2 active for *RISK CATEGORY*.

#### Quick-filter multi-selection facet

In difference to the simple multi-selection facet, the quick-filter variant is intended to manage a long list of facet values. In order to achieve that, the facet contains of two components:

- 1. An input field, that allows to quick-filter the list of facet values
- 2. A rectangle with a fixed height that contains a scrollable list of the facet values.



The basic behavior of the list of facet values is the same like for the simple representation. In addition the quick-filter variant offers a *select all* option, which will select all currently visible entries. For example now you can easily use an hierarchical prefix of your risks name in the *Name* facet, in order to quickfilter for a subset of the risks and can easily select all of them in one click.

By selecting a value it is positioned at the top of the list and the number of hits displayed in the *Risk Catalogue* view is updated accordingly.







### 6.2.4 How can I export a control to a PDF file?

To export a control to a PDF file, follow these steps:

- 1. Open the details view of the control (by clicking on the entry or using the context menu).
- 2. On the right side of the details view, you will find a button <. This button provides access to the *Options* side menu.
- 3. Click *Export PDF* **±** Export PDF to download the PDF file.
- 4. Once the download is complete, open the file to visualize its content.

The PDF includes all the information present in the details view. If a process was involved to create this version of the control, then the PDF file also contains the audit trail of that process.

**Note:** In order to create PDF files of historical versions, switch to the *History* view of the control. Then open the details of the desired version and follow Steps 2 to 4.

### 6.2.5 How can I sort entries in the Control Catalogue?

You have the option to sort catalogue entries by column headers. When holding the mouse pointer over a specific column header, if the column is sortable, a clickable icon with the shape of an arrow appears  $\uparrow$ .

By clicking on the arrow, the selected column is sorted. Depending on the data type, columns can be sorted alphabetically (A to Z) or by date (oldest/earliest dates).




The sorting order can be inverted by clicking again on the arrow.



### 8.4 Which filter categories are available?

*PROCESS*, *TASK OWNER* and *STATE* are three of the available facets. Within each facet, different values are shown based on the search results. The facet header shows the number of active facet values.

The other three facets are date-related: CREATED ON, DUE ON and FINISHED ON.

- **PROCESS**: The *PROCESS* facet gives you the possibility to filter tasks by process type. (e.g. *Action Management* or *Risk Assessment*).
- **TASK OWNER**: The *TASK OWNER* facet shows you user and user groups that are in charge of doing a task or finished a task.
- STATE: By using the STATE facet you can filter tasks based on the following states:
  - Pending: Existing tasks that are not finished yet.
  - Overdue: Existing tasks which its due date has passed.
  - Done: Finished tasks that you can keep track of.
  - Canceled: Tasks that were active when the process was canceled.
- CREATED ON, DUE ON and FINISHED ON: As date-pickers fields, you have the option to filter by:
  - All values, that are after or equal to a given Start date

- All values, that are before or equal to a given End date
- All values, that are after or equal to a given *Start date* and before or equal to a given *End date*

**Hint:** Combining values within the same facet makes the selection mutually exclusive "OR", whereas selecting values from different facets makes the selection mutually inclusive "AND". Please have a look at the following examples.

#### 8.4.1 How can I keep track of my finished tasks?

# 8.4.2 Do I have tasks for specific types of processes that belong to me and are *Overdue*?

Enter a wildcard "\*" as search term and submit the search. Select your user in the *TASK OWNER* facet and *Overdue* in the facet *STATE*. As a result, you can see all your *Overdue* tasks. Now, you can reduce this list of your *Overdue* tasks, by selecting specific processes in the *PROCESS* facet. (e.g. *Risk Assessment* and *Test of Completeness*).

### 8.5 How the role of a user changes the content I can find?

*PARTICIPANT*, *ANALYST*, *SUPERVISOR* and *ADMINISTRATOR* are the four available user roles. A role can be assigned to one or several users and a user can be granted several roles. *Search* takes into account role restrictions so that users receive restricted search results.

## CHAPTER 9

### Audit trail

#### 9.1 Overview

The Audit trail provides you a chronological overview of what happened in a given process instance.

In detail, the Audit trail:

- Shows when and by who the process was initiated.
- Tracks when and by who a task was finished.
- Tracks when, to whom and for what reason a task was delegated.
- Shows the active task of the process when available.
- Shows when, by who and for what reason the process was cancelled.

The following picture shows an Audit trail for a process that was launched by user "A". In this example, the first task of the process was finished by user "A". Then, a second task was initially assigned to user "A". Before user "A" finished this second task, the task was delegated to user "D" based on the reason given in the comment section. Now, user "D" is in charge of handling the active task.







If the process is initiated as a consequence of the set up of the *Scheduler*, the initiator in the *Audit trail* will be the System.

If the process is initiated manually by the user, the initiator in the Audit trail will be the user who launched the process.

If an *Action Management* process is triggered as a consequence of a finished process, the initiator in the *Audit trail* will be:

# 9.4 Why do I not have the Audit trail available for all versions of a risk or a control?

When a version of a risk or a control is created through the *BIC Process Design Connector*, then there is no *Audit trail* available.

*Audit trail* is only available in the risk/control *History* when the corresponding version was created by one of the *BIC Process Control Processes*.

# CHAPTER 10

### **BIC Process Design Connector**

#### **10.1 Overview**

The *Connector* allows you to import risks and controls from published BIC Process Design diagrams into BIC Process Control.

Imported risks and controls are added as new catalogue entries in BIC Process Control *Risk Catalogue* and *Control Catalogue*. When the import takes place, the data transferred from BIC Process Design to BIC Process Control is limited to the *shared set of attributes* between both applications.

The BIC Process Design Connector is also able to update risks and controls in BIC Process Design based on changes during processes that run in BIC Process Control. Details about updating risks and controls in BIC Process Design can be found *here*.

### 10.2 Import of risks and controls from BIC Process Design

When a diagram is published in BIC Process Design, the Connector is automatically triggered.

Once the publication takes place, modeled risks and controls of the corresponding diagram that has been published are sent to BIC Process Control and registered as new catalogue entries in the *Risk* and *Control Catalogues*. Once new entries are available, you can start managing risks and controls using available *processes*.

In order to have a proper behavior of the Connector you may consider the following hints:

- When a control is not connected to a risk, it will not be imported into BIC Process Control. Therefore, a control must be connected to a single risk.
- When a control is connected to more than one risk inside one diagram, the *Connector* will duplicate this control to the number of connected risks. Therefore, these different newly created controls in BIC Process Control share the single control from BIC Process Design. Because of this, it is recommended to connect a control with one single risk.

**Note:** Further information about how to publish a diagram can be found at the Governance chapter in BIC Process Design help documentation.

If you cannot find imported risks and controls in your BIC Process Control catalogues after publishing a BIC Process Design diagram, please check if your *system requirements* are correctly set.

#### 10.2.1 Attributes exchanged from BIC Process Design to BIC Process Control

BIC Process Design value fields for risks and controls are transferred to BIC Process Control. In most cases, an attribute is shared between BIC Process Control and BIC Process Design and the user input is available. (e.g. *Cause, trigger and impact* for a risk is introduced by the user and the value is transferred to BIC Process Control when the import takes place. If no user input is available, no data is transferred).

There are several BIC Process Control fields for risks and controls that will be automatically maintained by BIC Process Design Connector during the import. There are two possible options:

- An attribute is shared between BIC Process Control and BIC Process Design but the user has not given any input. (e.g. Execution Interval for a control is a user field in both applications. If the user leaves empty the input value field, the *Connector* automatically assigns the default value "Occasionally").
- BIC Process Design user interface does not have a user input field but the field is maintained by the *Connector* and shown in BIC Process Control. (e.g. Next Test of Design is not an available user field in BIC Process Design but is maintained by default with "today + 30 days" when a risk is imported).

Note: If you are using a customized BIC Process Design method, your exchanged attributes may differ.

Once the import takes place, BIC Process Control is the owner of the imported risks and controls. From now on, *these fields* are maintained by BIC Process Control processes.

\* The attribute *Risk Title* in BIC Process Design, allows to maintain a name for the risk based on its occurrence. If no such *Risk Title* is maintained, the *Connector* will use the BIC Process Design *Name* attribute to maintain the name of the risk.

\*\* By default the *Risk Rating* will not be imported from BIC Process Design into BIC Process Control. This is because in BIC Process Control the *Risk Rating* will be defined as part of *Risk Assessment* process. Therefore, the *Risk Rating* will be updated in BIC Process Design after being changed in BIC Process Control.

### **10.4 System requirements**

In order to be able to use the Connector, make sure that your system configuration meets the following requirements:

- The *Connector* has to be activated.
- The *Connector* has to be linked to a specific Repository. The repository of the diagram you want to publish needs to be registered to be considered by the *Connector* as a "valid repository". Usually, only the "production repository" is used to import risks and controls into BIC Process Control.
- BIC Process Control tenant default language determines from which language the content will be imported from BIC Process Design.

Please, ask your BIC Administrator in case of doubt.

# CHAPTER 11

### Administration

The Administration area offers you the possibility to manage Users: create, edit, search and delete them. You can also manage User Groups and User roles, as well as make other administrative settings here, like authorizing Processes to certain user groups and changing the UI configuration.

However, the Administration area is only displayed if you have the user role Administrator.

### 11.1 User management

Inside the *User management* administration, you have the possibility to see the entire user list and to create, edit, search and delete users.

#### 11.1.1 How do I create a new user?

First, navigate to the Administration area and select User management. Then open the OPTIONS tab on the right side and click on NEW USER.



In order to create a new user, you must enter the name and email address of the new user, and submit the form.

#### 11.1.2 How do I delete an existing user?

Navigate to the *Administration* area, select *User management* and navigate to the user you want to delete. Now, open the context menu by clicking on the three dots on the right side of the working area. Then choose *Delete*.



#### 11.2.1 How can I manage user groups?







### 11.3 User roles

In general, there are four different available user roles: *PARTICIPANT*, *ANALYST*, *SUPERVISOR* and *ADMINISTRATOR*.

#### 11.3.1 How can I visualize the list of existing user roles?

Only users with an *ADMINISTRATOR* role are able to visualize, assign and remove user roles according to their needs. Navigate to the *Administration* area and then click on *User roles*.

#### 11.3.2 How can I know which users belong to each role?







### **11.6 Archive**

In the Archive view, you can set a retention period for risks and controls.



*BIC Process Control* creates a new version for a control or risk each time a change is made. The retention period defines how long an archived version remains in the system. As soon as a risk or control version receives the status "archived", the currently defined retention period is saved in this version. Once the retention period has expired, the risk/control version is deleted from the system. If such a version was created by a process, like *Risk Assessment* or *Test of Design*, the process instance and its tasks are removed as well. This will only happen, if the process instance is finished and there are no other history entries referencing to it.


Here you can set the number of months as retention period for versions of risks and controls. By default the system will use a retention period of 120 months (10 years).

# **11.7 BIC Process Design Connector**

In case your tenant has a connection to BIC Process Design the Administration view offers a tile called *BIC Process Design Connector*.



Here, when triggering the *SYNCHRONIZE* button, the BIC Process Design Connector will update all risks and controls based on the publication stage of the relevant repositories of your BIC Process Design tenant. This operation may take some time. In case of identifying differences a new version of that risk or control will be created. Active tasks / processes are not effected by these new versions. They will still rely on the state of information that was available at the moment of starting the process.

# 12.1 What information is shown inside your Profile?

You can see:

- Your profile image.
- Your user name.
- Your email address.
- The group/s your user belongs to.
- The role/s your user has assigned.

# 12.2 How can I change my profile image?

You can easily do this in two different ways:

- By clicking on the circle that is right above your user name.
- By clicking on the CHANGE PROFILE IMAGE button, which is located on the right side as part of the Options menu.

In both cases, a file selection pop-up will appear right after the click.

The "*PDF Export*" contains the content displayed in the detail view as well as the information about the validity period of the exported version. If the exported version was created by a workflow, the export also contains the audit trail of it.

The filter facet "*Status*" in the search now provides information on the number of matching hits, as was already the case with filter facets such as "*Process*" or "*Task owner*".

User can now identify the owner of an blocking active predecessor task, independent if such task is owned by the user itself or someone else.

Administrators can now manage the members of a user group directly inside its group details view.

The "*Risk Control Matrix*" and the Excel exports of the risk and control catalog now contain the technical IDs of the risks and controls. In addition, the technical IDs of the risks and controls are also included in the task export if the task 's process takes place in the context of a risk or control. This enables Power users to create further evaluations based on the generated outputs. Customers who already have customized export templates will need to update their templates to benefit from this improvement.

The Action Management Catalogue can now be filtered by the Corrective Action property.

Administrators can now execute bulk operations inside the search view. They can do a *bulk task delegation* or a *bulk process cancellation* based on all tasks that match the the search term and the selected filter criteria. Especially the bulk task delegation will be very handy when user changes their roles in the company or must be replaced for other reasons. Bulk operations will only affect active tasks.

For archived versions of risks and controls, BIC Process Control now manages a retention period. Inside the *Archive* section administrators can define the retention period for risks and controls separately. Whenever a risk or control gets updated, the former "active" version will now count as archived and will be updated with the currently defined "*Retention period*" and based on this a calculated "*Retention date*". The details view of each archived version contains a new section "*Archive*" that shows both new properties.

#### To improve in general the handling of multi-selection facets, BIC Process Control now supports two types of visualization:

- Simple multi-selection facet (the already known visualization)
- Quick-filter multi-selection facet (new)

In difference to the simple multi-selection facet, the quick-filter variant is intended to manage a long list of facet values. In order to achieve that, the facet contains of two components:

- An input field, that allows to quick-filter the list of facet values
- A rectangle with a fixed height that contains a scrollable list of the facet values.

The Quick-filter visualization will automatically used to show a multi-selection facet, if it contains more than 15 facet-values.

The views *Search* and *Running processes* now offer an export option, providing additional information about the shown tasks. In addition to the basic task information, the export shows information about the process to which the task belongs. It also tells if the process is executed in the context of a specific risk or control.

Similar to the already known simple *Export* option available for the *Risk Catalogue* and *Control Catalogue*, the *Action Management Catalogue* now offers an export option as well.

The daily e-mail notification now only contain entries for still active tasks. In the past users may received a notice about new tasks which were finished on the same day. In order to further reduce the amount of individual e-mail notifications send by the system, an individual notification for a task delegation is only send if the delegated task has reached its due date or is already overdue.

The mandatory *Next Date Of.*.. fields inside the different forms are now turned into optional if the interval selected by the user for that particular process type is either "On demand" or "Occasionally".
